Where existing buildings or walls are to be demolished, these should be clearly shown. The proposed plans should be shown in context with the site boundary and any existing adjacent buildings. Applications for change of use need to be accompanied by floor plans, annotated where helpful, to indicate the extent of the existing and proposed use within the land or building. All drawings must include a scale bar showing lengths of 1m and 10m, and key dimensions. <b>Ownership Certificate (A, B, C, or D and Agricultural) – where applicable</b>	All Application Types	Under the 1990 Town and Country Planning Act (read in conjunction with Article 7 of the General Development Procedure Order 1995) all applications for planning permission must be accompanied by the relevant certificates concerning the ownership of the application site. Please ensure you have completed the Ownership Certificate (A, B, C or D as applicable), the Agricultural Holdings Certificate (except for advertisement consent only applications), and the declaration. Ensure you sign and date each of these sections – otherwise, your application is likely to be invalid. For a certificate an ‘owner’ is anyone with a freehold interest or a leasehold interest the unexpired term of which is not less than 7 years. Certificate A must be completed when the applicant is the sole owner of the site. Certificate B must be completed when all of the owner(s) of the site are known. If Certificate B has been completed notice must be served on all of the owners of the site in question. Certificate C must be completed when some of the owners of the site are known but not all. Certificate D must be completed when none of the owners of the site are known.  The Agricultural Holdings Certificate is required whether or not the site includes an agricultural holding.
